BUSINESS:

Scholarship Recipient: Saffron Jensen was introduced by Susan Voeltz as the winner of the Jane Klausman Women in Business scholarship. Saffron is a student at St. Cloud State who is studying business and technology.

District 7 Meeting Delegates and Alternates:

The District 7 meeting will be held in Kansas City on September 13-16, 2019. Our club is allowed two delegates. Debra Kellerman and Joal Peitz are going so they, as President and Vice President, will be the delegates. Debbie Grant made a motion to nominate Debra Kellerman and Joal Peitz as the delegates, and Linda Linn and Mary Nimmerfroh as alternate delegates. Nancy Fischer seconded the motion.
